Amends the Foreign Exchange Market and International Capital Regulation (RMCCI)

The Board of Governors of the Central Bank of Brazil, in a session held on 1 September, 2005, based on Law no. 4131, of 3 September 1962, Articles 10 and 11 of Law no. 4595, of 31 December 1964, Article 12 of Law no. 7738, of 9 March 1989, Law no. 7766, of 11 May 1989, Law no. 10755, of 3 November 2003, Provisional Measure no. 2224, of 4 September 2001, Resolutions no. 3265 and 3266, both of 4 March 2005, as well as Resolutions 3311 and 3312, both of 31 August 2005, and taking into account Article 2 of Circular no. 3280, of 9 March 2005, decided to:
